### Cruising in a Studebaker

Thanks to Big Dan Pfeiffer for writing the article, taking the photos, and for permission to reprint from the Southsider Voice newspaper's Sept. 29, 2010 Issue.

Joe Bacon met his future wife, Nancy Drews, in 1969. Little did he know at the time that it would lead him to become a Studebaker nut.

Around the same time, Nancy's parents, **Earl** and **Helen Drews**, bought their first Studebaker, a '63 wagon, for cheap, reliable transportation. But they really liked it and Studebakers in general and began collecting



them. At one time they had as many as 15 cars sitting all around their house on the northwest corner of Madison and Mills avenues. They became involved with the Studebaker Drivers Club and soon began to restore their first car, a '57 Golden Hawk. Throughout the years, 75plus Studebakers would flow through Earl and Helen's collection!

Joe and Nancy were married in 1971, and Studebaker fever soon spread to them as well. They bought a red '60 Silver Hawk, driving it for several years and refurbishing it along the way. They, too, joined the Studebaker Drivers Club, and the iconic cars became the brand the couple drove until 1983. During that time, from the early '70s until they started their family in the early '80s, Joe and Nancy bought and sold more than 100 Studebakers!

Raising their children, **Joanne** and **Tony**, became a top priority, causing them to give up the old-car hobby from 1983 to '93. Then Joe bought a red '70 Corvette for Nancy's everyday driving use. By the fall of '93, they began to realize that not only was it not going to be a practical car with two young children, it wasn't going to be a good choice for winter either. So they were back in the hobby after buying an additional everyday car for Nancy.



Joe's love was always the old Hawks, so in 2002 he began his search for one and found a 1956 Golden Hawk on eBay. It belonged to a Boston man who had owned it for 20 years. As it turns out, the old cruiser had quite an



interesting history. It was one of only nine Golden Hawks built in South Bend in 1956, with

the Glenbrook Green and Seafoam Green two-tone paint scheme. Three others were built at the Los Angeles factory, making it



the rarest color of the '56 model year. In 1982 the man found the car languishing in an Arizona junkyard, where it had been for years. He bought it, hauled it back to Boston and began a yearlong restoration,

driving it very little before displaying it in the Massachusetts Institute of Technology Museum for 10-plus years before selling it. Upon sitting idle for more than a decade in the museum, the seals, hoses, etc. had dried up, causing the Hawk to spring a leak almost every time Joe and Nancy took it out. They drove it for two years and then began a three-year body-off frame restoration, which resulted in an award-winning show quality. The car is powered by its original 352 Packard V-8 engine and equipped with a four-speed Ultramatic transmission. 1956 was the only year that Studebaker used a non- Studebaker engine. Studebaker and Packard merged in 1955, and the powerful 352 Packard V-8 was chosen for the Golden Hawk, making it one of the fastest production cars of 1956.



Joe and Nancy's Golden Hawk is driven as often as possible from spring through the fall and turns heads everywhere. On really nice days, Nancy drives this beauty to work at Kridan Business Machines on Troy Avenue. Keep an eye out for it. Until next week, keep on cruisin'!


Incoming new **President Brian Reeves** held an informal meeting. Outgoing **President Chuck Kern** was not able to be at the meeting due to being in the

### Dear Buddy,

I hope you can help me with a nagging problem I have. I own a 1963 Avanti and when I take it out we often have people come up and tell us all sorts of stuff that is incorrect, or I think is incorrect. For example one guy at a car show told me that his uncles' neighbor's friend's cousin by marriage's step dad had an Avanti just like mine, but it was blue with a bench seat and had a Packard engine with a turbo and the body was made from aluminum! It was a prototype built in 1956 and had a bullet nose! It was given to President Eisenhower by the original Studebaker designer's wife and Eisenhower gave it to Vice President Nixon. Nixon gave it to this guy's uncles'

neighbor's friend's cousin by marriage's step dad who was the door man at the Watergate building. This car sat in an old chicken coop with a cover that still had the Presidential seal at the guy's uncles' neighbor's friend's cousin by marriage's step dad's grandma's house. It stayed in the old chicken coop until rare aluminum eating terminates ate it. The remainder of the car was confiscated by the Secret Service and now is stored somewhere near Dayton, Ohio.

The Studebaker designer's wife told the uncles' neighbor's friend's cousin by marriage's step dad that her husband who is now deceased was General Eisenhower's driver in Europe during WW2 and one day he was driving the General somewhere in France when they saw a French car that General Eisenhower took a liking to. General Eisenhower instructed this guy, who was the General's driver at the time to make some drawings of the car so he did. After the war the General helped his driver get a job at Studebaker working as a designer with instructions to build this car they saw in France. It took years but he got it done as a prototype and when Raymond Loewy saw it he recognized it as a car he designed and built as a young man in France and left behind many years before. According to the designer's wife, Lowie ordered the car destroyed and fired her husband for stealing his design. Her husband got the car out the back gate and called Eisenhower who then took the car from him and gave him a job as Mamie's driver.

Loewy was then so obsessed with the car that he wanted to produce it here in the US and in 1961 he had his chance, and the Avanti was born but without the bullet nose.

OK Buddy, is any of this true? It sounds like a true story to me, but I don't know for sure.

As an Avanti or Studebaker owner you will hear all sorts of things from some of the Studebaker experts that you will run into at car shows and most of it is not true. I try to respectfully correct the things I can but sometimes people can be so set in their ways it's just not possible. I guess one way to look at it is these people have a genuine interest and mostly good memories they want to share about Studebakers.

But in this case the story is absolutely correct and by the way I have the original car cover with the Presidential seal from that very car! My grandpa was on the Secret Service detail that removed the car from the chicken coop and he held on to the cover as a souvenir.

I'm planning to sell it on Ebay but if you want it I can make you a good deal on it, but it will not be cheap. Give me a call and we'll talk. By the way, the Presidential seal is worn off, but it's real as you know, trust me. I also have the Bullet nose that President Eisenhower had made to look like the Presidential seal, but I want to hold on to that and it's not for sale, sorry.
